GET PREPARED:	做好准备：
<p>Ensure that all important documents are in a safe place where family members can access them.</p> <p>Make a plan with family in the event you or a family member is detained by ICE, including identifying a caretaker for your children.</p> <p>Memorize important phone numbers.</p> <p>Consider consulting with an immigration attorney.</p>	<ul style="list-style-type: none"> • 确保所有重要文件均存放在安全的地方，以便您的家人可以找到。 • 与家人一起制定计划，以防您或您的家人被 ICE 拘留，计划中应当为您的孩子确定一名看护人。 • 记住重要的电话号码。 <p>考虑咨询移民律师。</p>
YOU HAVE RIGHTS:	您享有的权利：
<p>You have the right to remain silent and to contact an attorney.</p> <p>You have the right to due process and to have your case heard before a judge.</p> <p>You have the right to say no to being searched or having your home searched unless ICE has an arrest warrant (not a removal order, etc). Agents do not have the right to search you or your belonging without your consent or probable cause.</p> <p>You have the right to ask ICE to leave.</p>	<ul style="list-style-type: none"> • 您有权保持沉默并联系律师。 • 您有权诉诸正当程序并提请法官审理您的案件。 • 您有权拒绝对您搜身或拒绝对您家进行搜查，除非 ICE 有逮捕令（而非驱逐令等）。如未经您的同意，或是无合理原因，特工无权对您搜身，也无权搜查您的财物。 <p>您有权要求 ICE 离开。</p>
IF YOU INTERACT WITH ICE	您在与 ICE 打交道时：
<p>Do not volunteer ANY information.</p> <p>You do not need to provide your immigration status or place of birth.</p> <p>If ICE enters your home without your permission, probable cause, or a warrant, clearly state that you do not give them permission to enter or search your belongings.</p> <p>Do not lie or present any false or fraudulent documentation, including a fake name.</p> <p>You do not have any obligation to sign any document without speaking to an attorney.</p> <p>Do not sign a document you do not understand.</p>	<ul style="list-style-type: none"> • 不要主动提供任何信息。 • 无需提供您的移民身份或出生地信息。 • 如果 ICE 在未经您的许可、无正当理由或搜查令的情况下进入您家，请明确声明您未授权他们进入或搜查您的物品。 • 不要撒谎或提供任何虚假或欺诈性文件，包括假名。 • 在与律师交谈之前，您没有义务签署任何文件。不要签署任何您不理解的文件。

<p>If you feel safe, document the event using your phone (via video or audio recording). If ICE shows up to your home or place of work, ask to see a warrant before you open the door.</p>	<ul style="list-style-type: none">• 在确保安全的情况下，您可以使用手机记录该事件（通过视频或录音）。 <p>如果 ICE 出现在您家或工作场所，请在开门前要求其出示搜查令。</p>
